The Sumter County Board of Commissioners does hereby announce that the millage rate will be set at a Work Session meeting to be held on August 13, 2019 at 6:00 p.m. at the Sumter County Courthouse - Board of Commissioners' meeting room and pursuant to the requirements of O.C.G.A. Section 48-5-32 does hereby publish the following presentation of the current year's tax digest and levy, along with the history of the tax digest and levy for the past five years.
